Site District 6E-16 report is in phase 1 of an expected 2. Hopefully, we will have a final approved report by end of next fiscal. Our planning on this is in pencil since it is in a state of constant flux. This year we are working at compiling, compiling, compiling, all the various info items that exist, along with some limited field work, and drafting the skeleton of the report with some draft text. Next year we will undertake field reconnaissance where able (mostly private land) and complete the text. At this point, I can't even think about taking each candidate site to confirmed status! That could be an entire career!

I suspect that this site district report will be used to fill the gap in landscape level planning initiatives of the province (existing and upcoming), and to encourage municipalities to recognize and protect the natural areas despite being only 'candidate ANSI's'. I am, with great glee, not a planner! My task is to prepare the ecological information tool(s) to provide to planners at all levels, so that they can do their fine work.
